

'Draft Decision' – Wigtown area

Notification under section 49(4) of the Communications Act 2003

Draft decision by Dumfries and Galloway Council in response to a proposal by British Telecommunications plc for the removal of public call boxes pursuant to part 2 of the Schedule to a Direction published by Ofcom on 14 March 2006 ('the Direction')
